Kevin R. Hoben, President and CEO, indicated the Company's 3rd Quarter Revenues were down \$567,000 (3.1%) from Revenues in the 3rd Quarter 2007, however Net Income improved \$563,000 (30.8%) over the same period. Similarly, Revenues for the first nine months of 2008 were \$4,299,000 (7.8%) below Revenues in the same period in 2007, but Net Income increased \$885,000 (16.1%) over the same period.

Revenue for the nine-months ended September 30, 2008 reflects continued weakness in the residential construction industry, which was offset somewhat by gains in market share in residential, non-residential and international construction markets. Net income for the nine-months ended September 30, 2008 rose primarily, as a result of improved margins related to decreased manufacturing costs, and to a lesser extent a decrease in marketing costs associated with reduced volume and reductions related to the closure of legal settlement costs.
