Kevin R. Hoben, Chairman and CEO, announced that the Company’s Net Sales for the first quarter of 2021 were \$30,863,000 compared to \$25,266,000 during the first quarter of last year, increasing \$5,597,000 or 22.2%. Net Income was \$6,267,000 for the first three months of 2021 versus \$4,344,000 during the same period last year, increasing \$1,923,000 or 44.3%. In contrast to the first quarter of last year which was impeded by the pandemic, the first quarter of 2021 reflects the Company’s best first quarter on record.
